



**WAIVER AND RELEASE RE: EVENT PARTICIPATION**

4. He/She is fully aware of the potential risks involved and the potential hazards connected with participation in the Event;
5. He/She voluntarily assumes full responsibility for these acknowledged risks and hazards;
6. He/She agrees to indemnify and hold harmless the Releasees from any loss, liability, damage or costs, including court costs and attorney fees that they may incur as a result of his/her participation in the Event, whether caused by the direct or indirect negligence of the Releasees, or otherwise; and
7. It is his/her express intent that this Waiver and Release shall bind the members of his/her family and spouse, heirs, assigns, and personal representative.
